This Memorandum of Understanding is made and executed on 19<sup>th</sup> November 2021 at Vijayawada.

BY AND BETWEEN

Department of Physics, SRR & CVR Government Degree College (Autonomous), Vijayawada functioning under the aegis of Commissionerate of Collegiate Education, Government of Andhra Pradesh situated at Machavaram, represented by Dr. K. Bhagya Lakshmi, Principal, hereafter called as 'SRR & CVR Government Degree College (Autonomous), Vijayawada' Who is duly authorized to sign and execute the MoU.

Suraj Krishna Greenaries, an authorized agency of ITC having its principal office situated at D.NO-37/1052-A1, Nehru Nagar, Kadapa-516002. Ph:8309657266 and Represented by Mr. K.Rama Chandraiah, Managing Partner referred as "Suraj Krishna"

Being the Second Part

Whereas SRR & CVR Government Degree College (Autonomous), Vijayawada has agreed to educate their students on waste management and form Swachh: WOW club in the college with the students to spread the message of source segregation to other students, and also agree to collect and handover the dry recyclable Paper.

**1. NOW THIS MOU WITNESSETH AS UNDER:**

This is an agreement for a synergic alliance between SRR & CVR Government Degree College (Autonomous), Vijayawada and Suraj Krishna Greenaries for the social cause of recycling of Dry Waste Paper and Environment Protection through recycling.

**2. Time period:** This MOU shall be for a period of 2 years from date of signing MoU.

**Roles and Responsibilities of SRR & CVR Government Degree College (Autonomous), Vijayawada:**

- a. To ensure source segregation of dry and wet waste at college premises through its Teaching staff, housekeeping staff and Students.
- b. SRR & CVR Government Degree College (Autonomous), Vijayawada will give away any kind of paper waste, to Suraj Krishna Greenaries at price agreed mutually. Suraj Krishna will pay as rates mentioned below:

White paper & News Paper: Rs.10/kg.  
Carton Boxes: Rs.2/kg.

- c. SRR & CVR Government Degree College (Autonomous), Vijayawada shall form Swachh WOW club in the college with Student Volunteers and adopt nearby Schools or Colonies to promote Source Segregation through student volunteers.
- d. SRR & CVR Government Degree College (Autonomous), Vijayawada shall motivate students to bring dry recyclables paper from their home and donate to WOW initiative.
- e. SRR & CVR Government Degree College (Autonomous), Vijayawada shall provide students for Internship in WOW Program.

**3. Roles and Responsibilities of Suraj Krishna Greenaries:**

- a. ITC-WOW team will impart training to the students and housekeeping staff on source segregation and through them inculcate the habit of source segregation among the other students.
- b. Suraj Krishna Greenaries will collect dry recyclable waste and old records from SRR & CVR Government Degree College (Autonomous), Vijayawada and bring to the Hub for sorting and baling of the material collected and dispatch to recycling industries.

- c. Suraj Krishna Greenaries shall coordinate with ITC and undertake necessary measures for dispatch of the sorted recyclables for recycling at its own cost.
- d. Suraj Krishna Greenaries will make payment to SRR & CVR Government Degree College (Autonomous), Vijayawada directly into their accounts for the dry recyclable paper waste collected against the accurate weight, The payment shall be made no later than 15 days from the date of payment request raised by the college. Franchisee on the request of SRR & CVR Government Degree College (Autonomous), Vijayawada may give New Notebooks and Stationery against the value of dry recyclable paper lifted.

#### 4. Performance of Obligations

- a. The details laid out in this MOU, notwithstanding the essence and spirit of this MOU is an understanding between SRR & CVR Government Degree College (Autonomous), Vijayawada and Suraj Krishna Greenaries.
- b. Any notice or other communication under or in connection with this agreement shall be in writing in the English language and shall be delivered personally or sent by way of e-mail to the party due to receive the notice or communication at its address set out in this contract or such other address as either party may specify by notice in writing to other.

- c) The MoU does not hold any legal/financial/administrative consequences after being terminated by both the parties or at the behest of any of the parties.

## 6. Amendments

This Agreement and the Schedules together constitute a complete and exclusive understanding of the terms of the Agreement between the Parties on the subject hereof and no amendment or modification hereto shall be valid and effective unless agreed to by all the Parties hereto and evidenced in writing.

## 7. Duration of the MoU:

The duration of this MoU will be for TWO years from the date this MoU has come into effect as specified in the first paragraph and can be extended for another two years with the mutual written consent of both the institutions.
